    - 1. Crystal Meth
      - a) Shards vs powder
      - b) Super cheap
      - c) 99%/100% purity
      - d) 2020 SLMA meth deaths = 181
    - 2. Heroin/Fentanyl
      - a) Heroin sourced from Chicago street gangs
      - b) 55% purity
      - c) 2020 SLMA heroin deaths = 89
      - d) Fentanyl lab created
      - e) Incredibly addictive
      - f) 100x stronger than morphine; 50x stronger than heroin
      - g) Replacing the heroin user demand
      - h) 2020 SLMA deaths = 782
