II. Approve meeting minutes: 4:05-4:06 The minutes were approved.

III. Youth Update: 4:06-4:10 Gabriel Talsky provided an update on the activities the students executed for Red Ribbon Week. They hosted a trivia contest throughout the week where students could answer the questions and winners were announced daily. The trivia questions were related to substances and the negative effects of them. About 100 students participated over the course of the week and was an improvement from last year. Students were also encouraged to wear red the last day of the week. There were fact cards on the lunch tables that changed daily.

The group also thought about a panel discussion after smaller, more casual discussions and some skill building opportunities for parents so they have something they can put into action.

B. Policy & Advocacy Group:

- 1. The group will take time to review other communities' social host ordinances and then discuss the following questions.
- 2. Questions to consider:
 - a) What aspects of these other social host ordinances do we like? Can we translate any of these pieces to Clayton's social host ordinance?
 - b) What would be our end goal of updating our social host ordinance?
 - c) Are there areas of our social host ordinance that we want to change, and if so, what?
 - d) What will be the foreseeable barriers to formally changing our social host ordinance?
 - e) What are the next steps?

The group looked at both the Clayton and City of Ellisville's ordinance (which was approved in 2020). We discussed the possibility that the challenge could be a tracking issue and not an ordinance issue. The police department is in the process of updating its tracking system. Jenny explained that when police arrive to the situation, there is officer discretion to determine if it would be more impactful to cite the parents for failure to supervise or to cite the underage youth with an MIP. The team will continue to look at more ordinances from other municipalities.

VI. Annual Member Survey Results: Cindy Pharis. 4:40-4:50

There were 12 respondents to the survey. All respondents felt the organization had a positive energy and spirit and a majority were pleased to be a member of the coalition. 50% of the respondents were neutral about the coalition's ability to make a positive impact. Results showed that we had a great coordinator. We should continue to plan and focus on the implementation and feedback loop. Respondents felt like their contributions were welcome and that the agenda outcomes were clear. Cindy recommended that we consider the length and frequency of meetings. Meaningful volunteer opportunities was a strength in the data. Diversity of membership is an area of improvement. Cindy encouraged us to think about our communication plan and the importance of having current members reach out to other community members to increase the diversity of membership.
