**IV. Community Spotlight: Skyla Barlow from St. Louis County Public Health**

**4:10-4:15 DPH Department of public health:** *Skyla is Interested in our work of prevention. They're funded by grant and are interested in working with Community Partners, Naloxone distribution. They're writing an action plan: opioid, stimulants, for 2022-24. Main initiative is drug education and prevention; They do drug take back, etc. An increase in cocaine and fentanyl is making its way into stimulants, so seeing a rise in accidental overdoses. Lt. Thuet said that CPD and Fire always have Narcan in vehicles and have brought some people back w/ it. Kim also said that every nursing office In the school district has it.*

Health Teachers at WMS are going to JBS to check out their program that they've been doing for 10 years;*

*Bridget McAndrew reported that anyone 18 years old could be charged as an adult -including older siblings- for social hosting. Jen Schilpzand said it'd be nice for the students to actually read this ordinance and discuss. Could this happen during certain classes: government, health or others? Committee discussed needing a fresh message for a campaign and contacting Laura Stanton soon to create one. Ways to get message out: yard signs, FB SDC, FB All in, Next Door, City of Clayton E-blasts, Ctr. of Clayton digital board in lobby, Parks and Rec. Digital Roadway Signs. Corporal Jen S. asked if we can send various sizes and formats for the messaging and she is going to email Kim S. a list of what is needed.*
